Whereas, except the above amendment, all other clauses of the Principal/original Trust Deed dated: 21.11.2009 remained unaltered and would in force in the same spirit.



- 11) A member of the Board of Trustee may resign and such a member shall 2009, 10 decease to be member upon the acceptance of his/her.
- 12) The Board of Trustees shall have the power to amend the terms of this trust instrument only for the efficient and successful achievement of the objects of this trust by unanimous decision but however, no such amendment shall prove repugnant to the provisions of section 2(15), 11, 12, 13 and 80(G) of the Income Tax 1961 and also no such amendment shall be carried out without the prior approval of the Commissioner of Income Tax having the jurisdiction over the trust.
- 13) The funds of the Trust shall be invested in the modes specified under the provisions of Sec. 13(1)(d) r.w.s. 11(5) of the Income Tax Act, 1961 and amerided from time to time. The funds and the income of the trust shall be solely utilized towards the achievement of the objects and no portion of it shall be utilized for payment to trustees by way of profit, interest and dividend.
- 14) The benefits of the Trust shall be open to all irrespective of caste/creed/religion.
- 15) In the event of this Trust being dissolved the properties/funds of this trust shall go to any other Trust/Institution having similar objective and which enjoys recognition U/s. 80G and /or any other relevant provisions of Income Tax Act, 1961 and in no case the asset/properties shall be distributed directly or indirectly among the Trustees or Authors if any.
